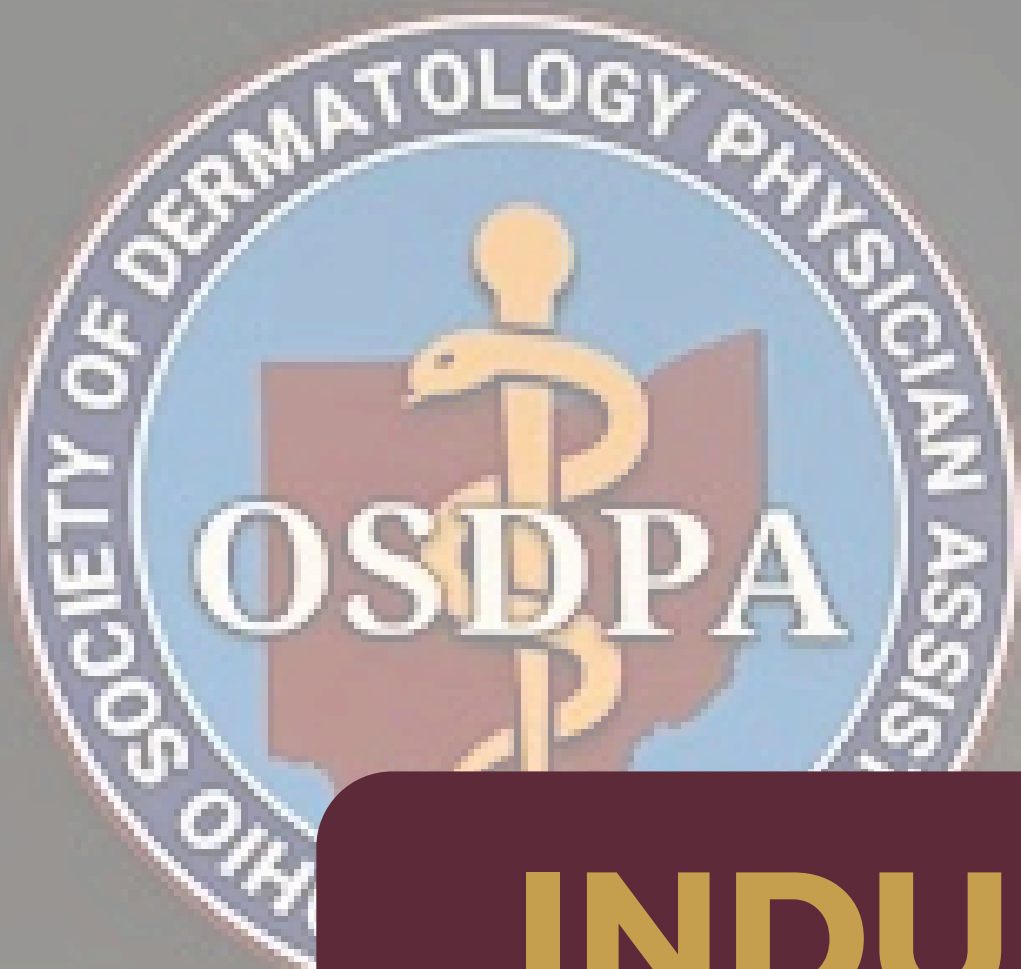

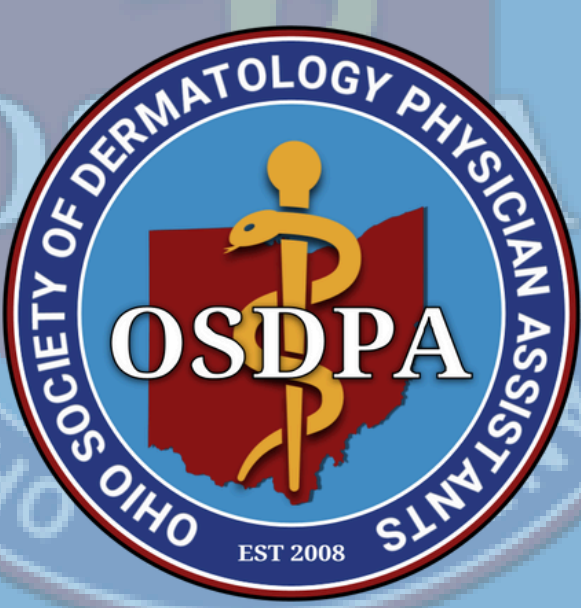

About The Day in Derm Conference

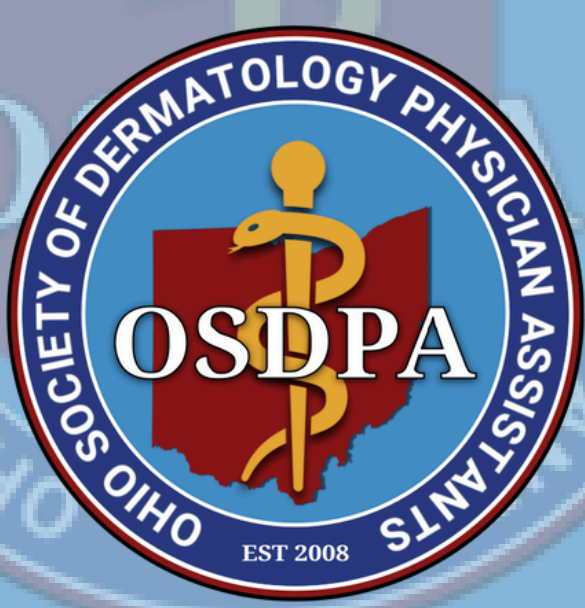
The 3rd Annual Day in Derm Conference, hosted by the OSDPA, offers a unique opportunity for sponsorship in the growing field of dermatology education. We are expecting to host over **80 attendees**, including physician assistants (PAs) and nurse practitioners (NPs) specializing in dermatology. The Day in Derm Conference has seen increasing engagement from members with over **50% of attendees participating in additional offerings past CME**, including but not limited to Career Lounges, Exhibit Hall attendance, Post-Reception, and the night before events.

A 2026 study found that **PAs and NPs accounted for 38% of prescribing clinicians in dermatology specialty care.**¹ The annual rate of increase in **specialty medication prescribing costs per prescriber-year was notably higher for PAs and NPs when compared to their physician colleagues, demonstrating a 32% annual growth rate versus 24% for physicians.**¹ By sponsoring the Day in Derm Conference, your company will gain direct access to this highly engaged group of healthcare professionals, furthering your presence in this dynamic and growing market.

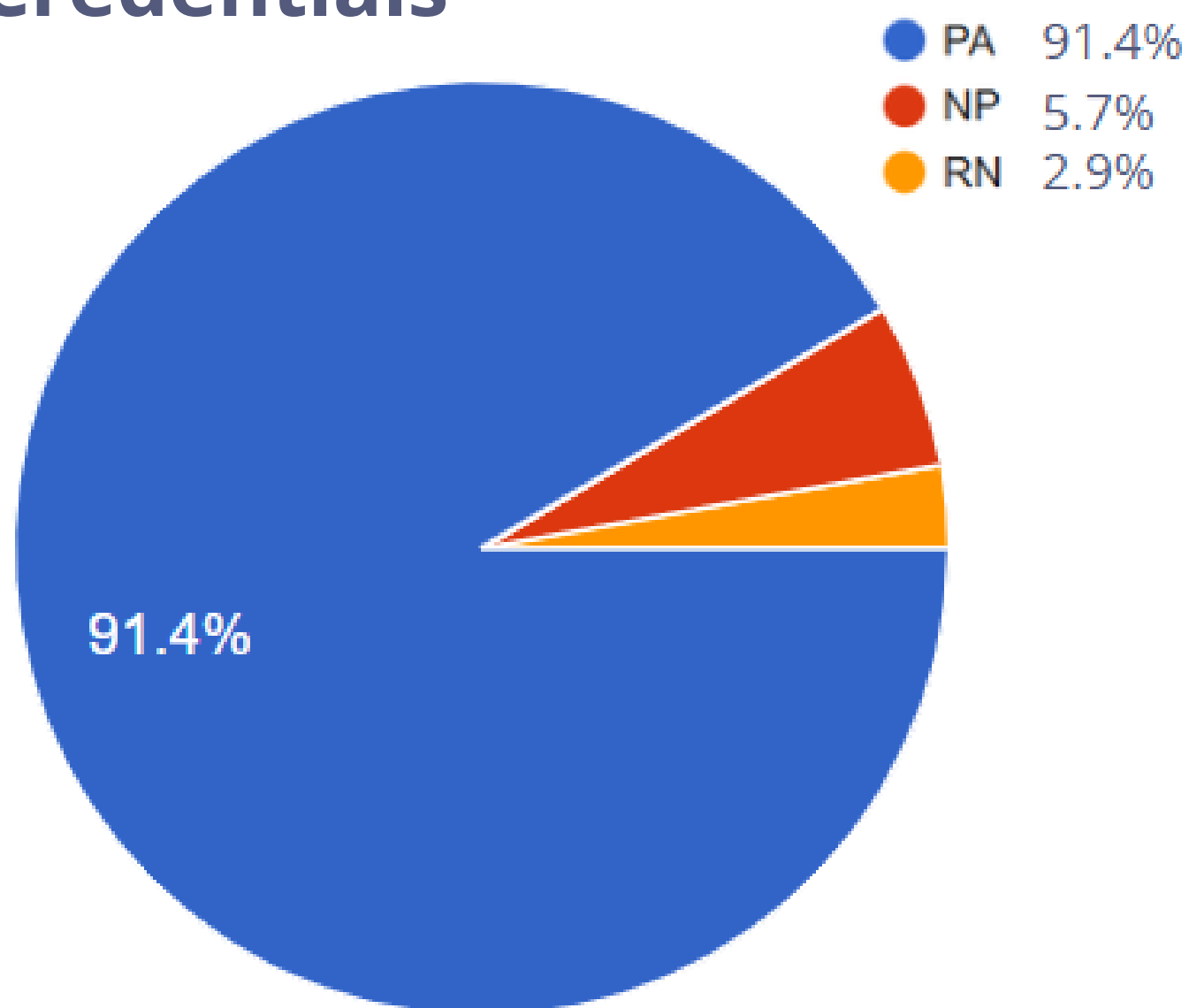

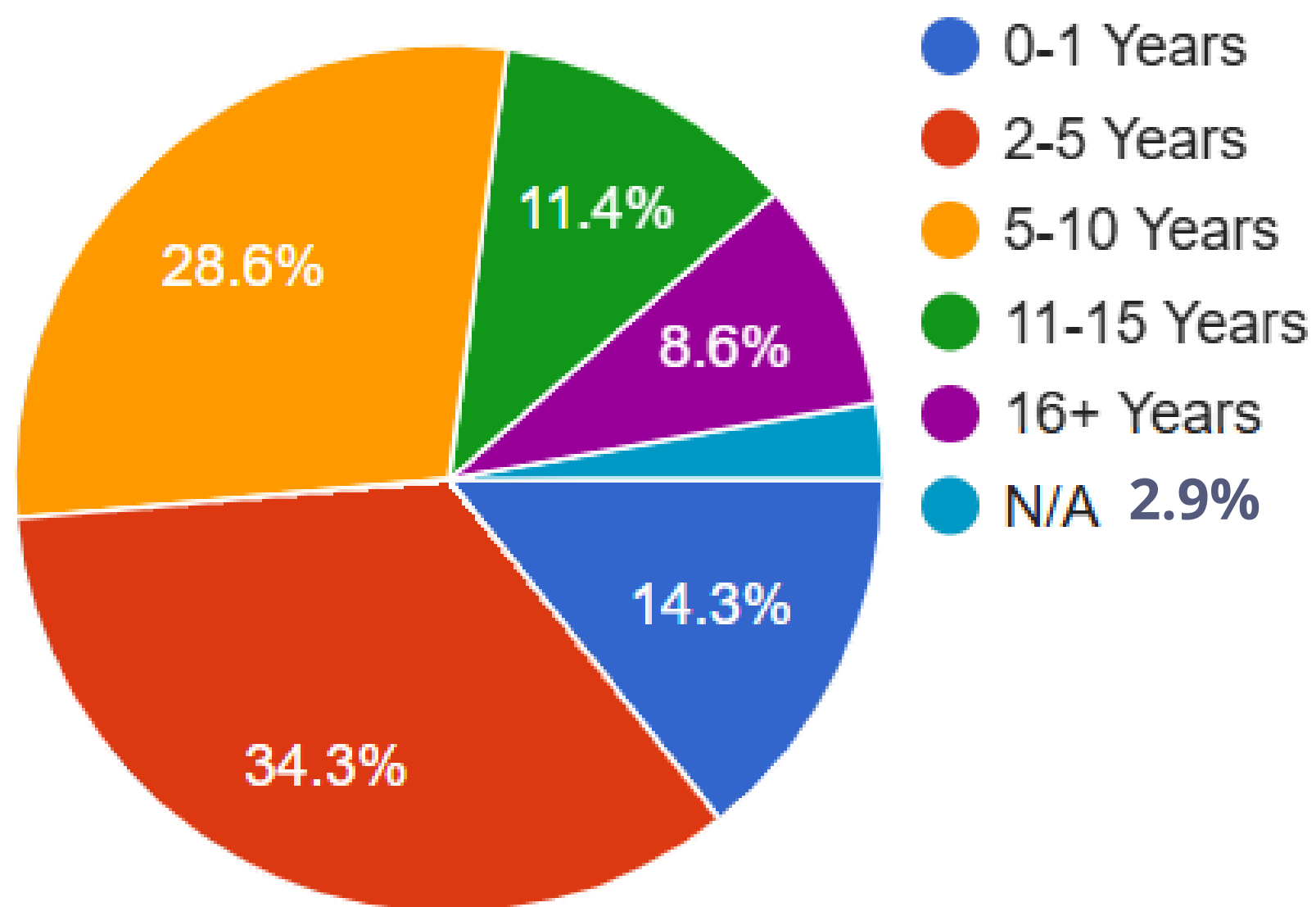

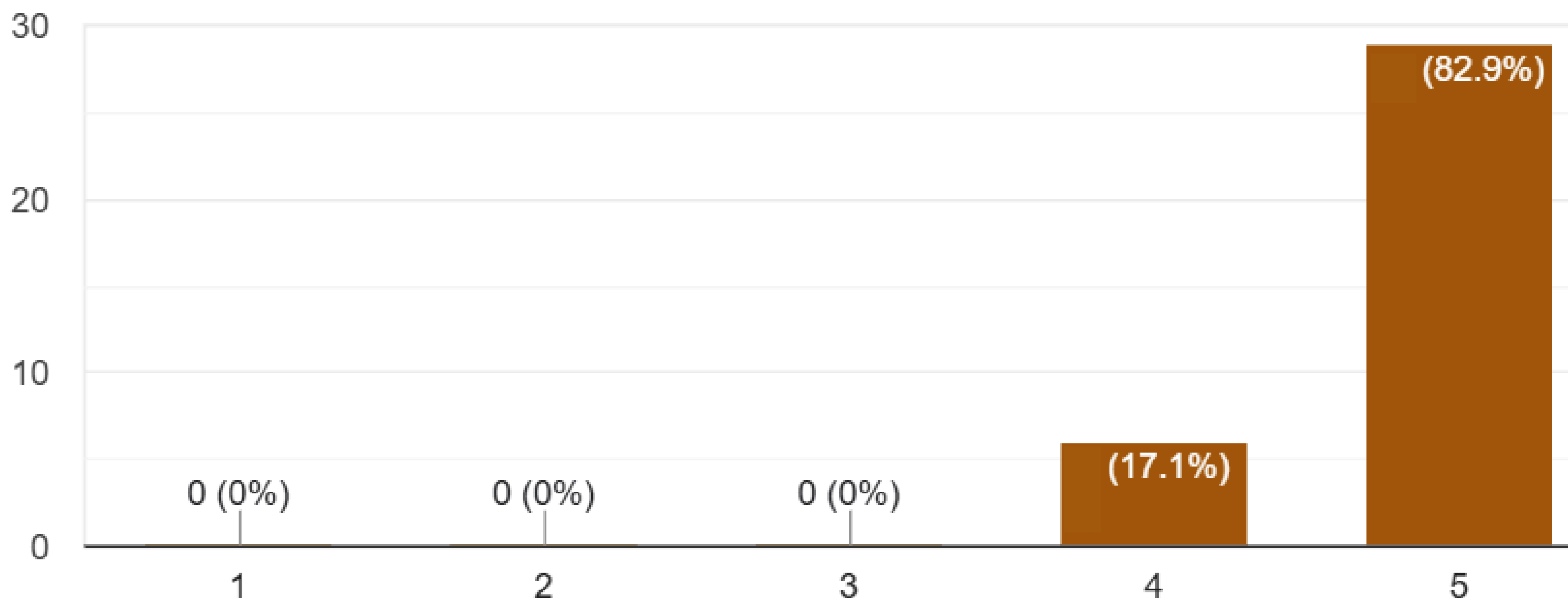

Attendees Years in Practice



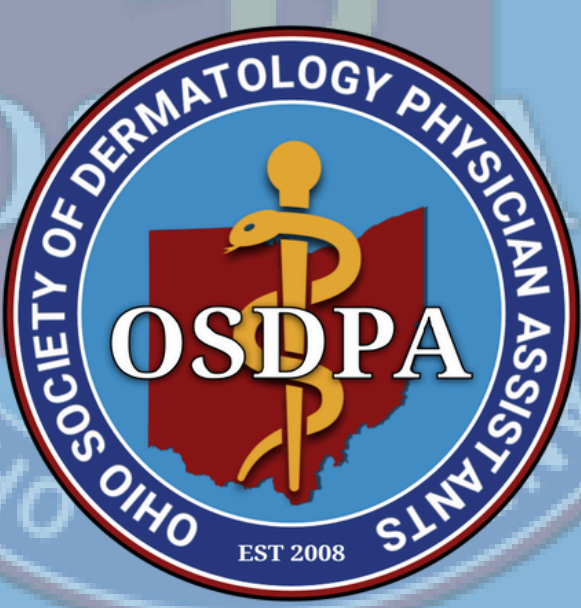

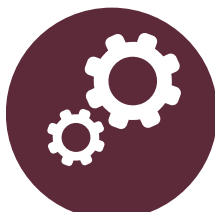

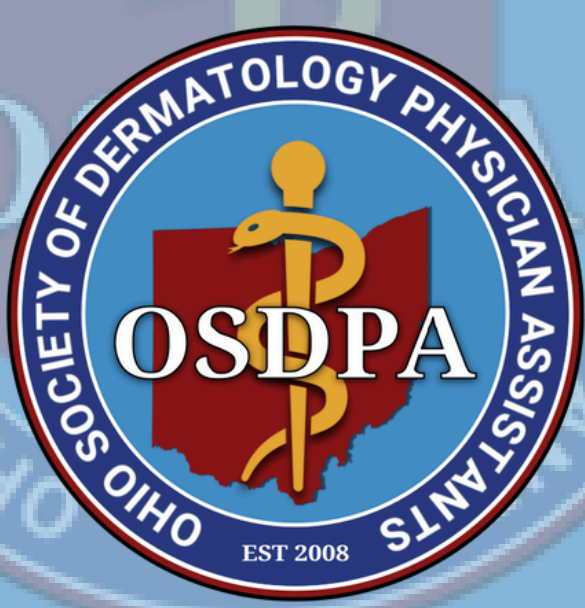

Registration

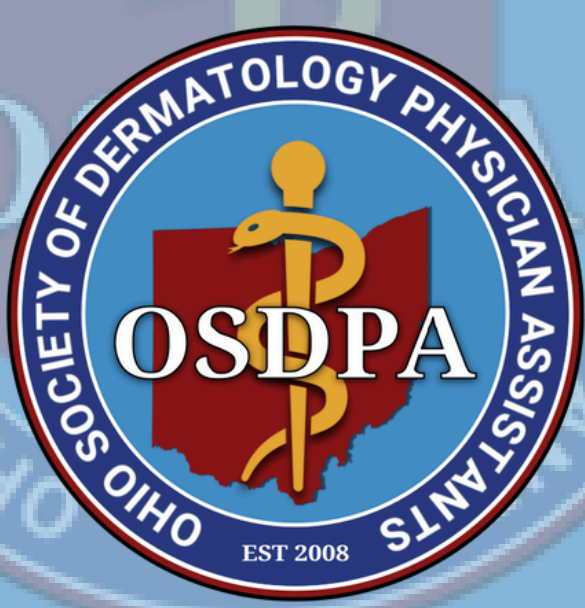

Neither the rights nor obligations under this Agreement shall be assigned or otherwise disposed of without the prior written consent of the non-assigning party. Any attempted assignment of this Agreement shall be null and void and shall constitute a breach of the agreement, resulting in cancellation at the discretion of OSDPA. OSDPA is the sole authority for resolving questions or issues arising from the interpretation of the following terms and conditions. The authorized sponsor signing the Agreement is responsible to ensure the company representatives who will be involved in any activity relating to the conference will be aware of and comply with these conditions.

ELIGIBILITY: Sponsors/Exhibits will be limited to those companies or other entities offering materials, products, or services of specific interest to attendees, as determined by OSDPA in their sole discretion. OSDPA reserves the right to determine the eligibility of any assets for display at Day in Derm 2026

SPONSOR CANCELLATION & REFUND POLICY: Notification of cancellation must be done in writing to ohiodermpa@gmail.com. The benefits provided to meeting sponsors start immediately upon payment or receipt of purchase order. No refunds will be given for any cancellations of a sponsor within 30 days of the conference. In the event of cancellation by the Sponsor (other than because of any restrictions enforced by government regulations), the following cancellation fees will apply

EXHIBIT ONLY CANCELLATION & REFUND POLICY: Notification of cancellation must be done in writing to ohiodermpa@gmail.com no later than October 8th, 2026, to receive a refund minus a \$250 administrative cancellation fee. No refunds will be given for cancellations received after October 9th, 2026.

INSURANCE: It is the responsibility of each sponsor/exhibitor to maintain insurance against injury to person or damages or losses of property in such amounts as the exhibitors deems adequate. Insurance protection will not be provided either by the OSDPA or the Hotel.

SECURITY: The exhibit area will be in a public space of the Hotel. OSDPA will not be providing security when the meeting is not in session. The meeting rooms should be locked but it is encouraged and recommended that nothing of significant value is left in the exhibit space during off hours.

LIABILITY & INDEMNIFICATION: The sponsor/exhibitor will be fully responsible for any claims, liabilities, losses, damages, or expenses relating to or arising out of any property of exhibitor or any other property where such injury, loss or damage is incident to, arises out of, or is in any way connected with exhibitor's participation in Day in Derm 2026. The exhibitor shall protect, indemnify, hold harmless and defend OSDPA, its officers, directors, agents and employees, and the Hotel and its agents and employees from and against any and all such claims, liabilities, losses, damages and expenses; provided that the foregoing shall not apply to injury, loss or damaged by or resulting from the negligence or willful misconduct of OSDPA, its officers, directors, agents and employees, and the Hotel and its agents and employees. In case any part of the exhibition hall is destroyed or damaged so as to prevent Day in Derm 2026 from permitting an exhibitor to occupy assigned space during any part of the whole of the exhibition period, or in case occupation of assigned space during a part or the whole of the exposition period is prevented by strikes, Acts of God, national emergency or other cause beyond the control of OSDPA, then the exhibitor will be charged for space only for the period the space was or could have been occupied by exhibitor; and the exhibitor hereby waives any claim against the OSDPA, its officers, directors, agents and employees for losses or damages which may arise in consequence of such inability to occupy assigned space. **FORCE MAJEURE:** In case of Force Majeure, OSDPA reserves the right to modify dates, time schedules, event plans and programs. In case of forced cancellation of the event, money paid by Sponsors/Exhibitors will be reimbursed, subsequent to proportional deduction of expenses incurred.

INTERPRETATION & APPLICATION OF TERMS & CONDITIONS: All matters in question not specifically covered by these terms and conditions are subject to the decision of OSDPA. Sponsors/Exhibitors agree to comply with all subsequent reasonable rules adopted by OSDPA for Day in Derm 2026. OSDPA may grant permission to exhibit, subject to such special conditions or limitations, as it is deemed necessary to assure that an exhibit satisfies the basic criteria for technical exhibits.
